Capabilities

- Referral (including teacher checklists, clinician observations, and other feedback)
- Informed Consent (including the electronic capture of signatures from parents, guardians, and others)
- Service Logging (including type of contact, type of case, date and time of session, duration, areas covered, and more)
- Reporting (either at intake or at the end of a service period)

Clinical Services also has the capability to attach external supporting documentation to individual student records, whether scanned or photographed (from an electronic tablet or other mobile device).
